OUR CHAPTER REPRESENTATIVE for the WSMTA State Conference will be chosen at the Adjudications Recital, by a majority vote of the LWMTA teachers in attendance. Each teacher will receive a program that indicates the students who would like to perform during the state conference. Votes will be tallied by committee and the Representative will be notified the following day.

- **The CHAPTER REPRESENTATIVE must have participated in MAP with two memorized pieces**
- **The same student may not represent the chapter two years in a row.**
- **If a student wishes to be considered as LWMTA's Chapter Representative, please be sure that the consent form is complete with signatures from the student and a parent.**
- **Also, please attach a copy of the student's rating sheet showing the adjudicator's signature, as proof that the adjudication was completed. (The adjudicator's comments may be covered up on the copy).**
